ABSTRACT

In addition to their manuscript (**maximum 6 pages**) authors are requested to also submit this extra “one” page containing only the Extended Abstract and a minimum of five and a maximum of ten Keywords. Please use this document to produce your Extended Abstract. The length of the Extended Abstract including text, tables, figures and the keywords is limited to a **maximum of ONE page**. The abstract should be written on a Letter format (216 x 279 mm or 8.5” x 11”) of paper with all margins equal to 25 mm (1”). Replace the above title of paper and name(s) of author(s) (**make sure you write the full first name and the full last name for each author**) and their contact information. **Do not add the title/rank of any of the authors such as Mr., Ms, Mss, PhD Student, MSc Student, Professor or alike. Do not add phone or fax number.** As shown above, if authors are from the same University or company then do not repeat the name and address of the university or the company for each one. The title of paper must not exceed two (2) lines.

Author(s) are required to submit their Extended Abstract in both MS-Word and PDF formats to the conference email address: acmbs2016@ucalgary.ca.

The file name of the Extended Abstract should be: **Abstract_###.doc (or docx)** and **Abstract_###.pdf**, where ### corresponds to the Paper ID that was assigned to your abstract submission. As an example: “Abstract_010.doc” and “Abstract_010.pdf”, where 010 corresponds to the unique paper ID.

In general, the extended abstract should be divided into 3 sections or paragraphs: Objectives, Relevant Results and Conclusions. It should not contain either references or acknowledgements. In the Objectives section, the main objectives of the conducted work as well as the underlying motivation should be presented. Alternatively, if the work deals with a case study, it should be generically described. Furthermore, this section should contain the information required for the interpretation of the results or to contextualize the case study. Detailed descriptions of processes, experimental setup or construction procedures should be presented in the full paper. The second section should present and discuss briefly the most relevant results obtained. The main conclusions of the conducted work should be presented in the last section.

We kindly request that you adhere strictly to all instructions in this template.

Keywords: Please provide a minimum of five and a maximum of ten keywords here. Separate the keywords with a semicolon. They should be written in Arial 10, and the line must begin with the word “Keywords:” boldfaced.
